Considering that Tennessee, as a state, reports 153.9 persons per square mile, the SCHRA service area has quite a bit less with an average of 65.77 persons per square mile. This data confirms that the SCHRA service area is predominately rural. The largest concentration of inhabitants is in Maury County with 132 persons per square mile. Maury County is the second largest per land area, behind Lawrence with 617.13 square miles, the largest town (Columbia) is located in Maury County. The second largest in population density is Bedford County with 95.1 persons per square mile.



Language


After English, Spanish is the predominant language in the area. When looking at the primary language of the population in

served in Maury, Coffee and Bedford counties. There are small numbers of families who speak Samali, Gujarati and Mandarin Chinese in the area. The HS/EHS program has all forms translated into Spanish and the Family Handbook translated in Mandarin as well. All written correspondence is translated into Spanish for families of whom Spanish is their primary language. Additionally, interpreters are available for Parent meetings, Policy Council and communication with the community. Bedford and Maury counties have multiple classroom staff who speak Spanish to meet the needs of the children. Marshall County continues to be a challenge in regards to hiring bilingual staff for the classroom, so the program has a DLL Coach that is onsite on a regular basis, with phone access at other times, to assist with any language barriers.



Head Start/Early Head Start enrollment from 2016-17 reflects that 10% of the children's primary language was Spanish. This is 6% higher than the community demographics. Thus, showing evidence that the program's outreach to Dual Language Learning families is showing success.

Literacy Skills

As noted in the table above, the service area as a whole has higher literacy scores than the nation, yet the majority is at or lower than the Tennessee state average. While 13% of Tennesseans lack literacy skills, 20% fall into this category in Lincoln County and 19% in Bedford County. This Literacy information is from 2003 and may be outdated, but no other information was found regarding literacy in our service area.



WIC Program in Services Area

In a majority of the service area, the prevalence of women and children participating with the WIC program has been on a steady decline. Even through the decline ten of the thirteen counties served exhibit higher instances of WIC

recipients than the Tennessee average. Wayne Co shows the highest number participating with the WIC program while Maury has the lowest percentage of participants.

The state of Tennessee has shown a 7.1% decline in participants between 2013 and 2016 while the service area has experienced a 12.8% decline in WIC participants. The reason regarding the decline in participants is possibly limited knowledge of the program because the other statistics regarding high risk infants reflect that the need for the WIC program continues to be present and seems to be increasing.


