Hiring Recommendation for Appointment – Executive Director: Chairman of the Board and Chairman of the Executive Director Selection Committee asked SCHRA HR Director Scarlet Patterson to present and review the Selection Committee's Recommendation for Appointment, presented in the form of a handout to the board. This position was posted on the SCHRA website, Indeed, and the Office of Head Start – ECLKC career page on April 3, 2025, following

the approval of the board in the Governing Board meeting on that date. The Executive Director Selection Committee met on April 30, 2025, to review the applications and evaluate the selection of candidates for interviews, which were conducted on May 5, 2025, at the SCHRA Central Office.

Of the three top candidates selected for interview, one declined, another withdrew after initially accepting, and one interview—conducted with the highest-rated applicant—was completed. Based on this interview and a comprehensive assessment of her credentials, the Selection Committee recommends Sara Brown, currently serving as Interim Executive Director, for appointment to the role of Executive Director. The proposed salary for the Executive Director position is approximately \$160,515. The Head Start Policy Council met earlier this morning and approved the Selection Committee's recommendation for Sara Brown as Executive Director. All offers are contingent upon the approval of the Office of Head Start.

Chairman Mangubat opened the floor for questions regarding this recommendation. Hearing none, he requested a motion to approve the committee's recommendation for Sara Brown as the next Executive Director of South Central Human Resource Agency. A motion was made by Mayor Blake Lay and was seconded by Representative Iris Rudder. Chairman Mangubat requested a voice vote, and all present voted in the affirmative. The motion carried.

Chairman Jim Mangubat informed those in attendance that the next Board meeting is scheduled for June 5. Regular notice has been provided to all members.

With all other business completed, a motion to adjourn was made by Mr. T. R. Williams and seconded by Mayor Blake Lay. Motion carried.
