**BUSINESS:** Mr. Keith Hundley, of CRI CPA's and Advisors, presented the **Audit for the fiscal year 2024-2025**. He reported that they issued an unmodified report with no findings on the agency's financial statements. As of June 30, 2025, the condensed statement of net position was as

follows: total assets of \$22,250,611, deferred outflows of resources of \$1,169,181, total liabilities of \$9,022,721, and deferred inflows of resources of \$647,847, resulting in a total net position of \$13,749,224. The agency's net position increased \$698,897 for the fiscal year. The total fund balance as of June 30, 2025, was \$2,211,527.


